Antitrust in the Age of Populism:

Is Antitrust Enforcement Too Lax?

Since the late 1970s, antitrust enforcement has singularly focused on the economics of "consumer welfare" or, more precisely, whether challenged conduct or a potential merger makes consumers better or worse off. Since the Great Recession, however, a growing chorus of academics, pundits and politicians have argued that these antitrust policies have led to a rise in corporate concentration across industries and increased income inequality, among other harms. The critics argue to reorient (or return) antitrust law to consider factors beyond consumer welfare, such as jobs, wages and income disparity. Proposed legislation calls for a "Better Deal" for the American people. This interactive program presents and debates this trend in antitrust law, its long-term prospects and its practical effects.

- 1. Why has antitrust regained the public interest in recent years?
- 2. What is antitrust consumer welfare and why is it the focus of modern antitrust enforcement?
- 3. What is the new populist antitrust movement (referred to by its critics as "Hipster Antitrust"), and how would it change antitrust enforcement?
